The Operating Department Practice Bachelors Programme prepares undergraduate students for eligibility to apply for initial professional registration. As a graduate in Operating Department Practice, students will have developed specific skills, knowledge and competence in their chosen subject. Student understanding will be underpinned by an ability to retrieve and use evidence and through reflection apply this to their own professional practice. As a graduate, individuals will demonstrate self-awareness and confidence in their own abilities and an emerging potential to supervise, manage and lead others. Graduates from the programme will contribute significantly to high quality person centred care across the lifespan. They will demonstrate the skills to manage their own continuing development and work effectively with other professionals in order to promote best outcomes of care.

These modules constitute the Programme for the BSc (Hons) Operating Department Practice. Five modules (120 credits) are offered at level 4, Seven modules (120 credits) are offered at level 5 and Five modules (120 credits) are offered at level 6. The modules are designed to reflect the nature of the perioperative environment; studying with other professionals allows an opportunity for sharing experiences, knowledge, skills and support. All modules have practice as their underlying focus.

## 4.2 PROGRESSION AND AWARD REQUIREMENTS

Students must complete year one modules in a sequential pathway. Students must pass all modules in year one before progressing to year two. Successful completion of year one / stage 1 is a pre requisite for entry to year two / stage 2. Student must pass all practice modules in year two / stage 2 before Updated January 2018

progressing to year three. Students in year two / stage 2 may carry over a maximum of two theory modules into year three (e.g. Module U43744 / U42128).

Successful completion of all practice modules (U42125 and U42126) year 2 / stage 2 and a minimum of three theory modules is a pre-requisite for entry into year 3.

Students may on successful completion of year 1 / stage 1, exit with a named Certificate in Higher Education: Perioperative Care.

If a student wishes to leave the Programme during stage 2, they will be eligible for a named Diploma in Higher Education: Perioperative Care. If they have taken and passed 240 credits at level 4 and above including at least 90 at level 5 or above.

On completion of year three, stage 2 students are eligible for a BSc (Hons) Operating Department Practice.

#### 4.3 PROFESSIONAL REQUIREMENTS

All of the above modules are compulsory requirements of the BSc (Hons) ODP Programme, successful completion of which allows the student to meet the requirements for eligibility to apply for registration as an ODP with the Health and Care Professions Council (HCPC).

#### SECTION 5: TEACHING AND ASSESSMENT

A wide range of teaching and learning strategies are employed. These encourage integration of knowledge, reflection and multi-professional co-operation, collaboration and the development of professional skills.

Teaching strategies primarily focus on student-led and student-centred approaches with educational staff acting as facilitators. Other traditional teaching methods: formal lecturer, discussion groups, seminars and skills lab sessions are used. In addition, all students will learn and be assessed in clinical practice; this element constitutes 60% of the Programme delivery.

In all modules there will be an emphasis on practice. Students will be encouraged to explore and challenge their existing knowledge in relation to their clinical experience.

The opportunity to engage in reflective analysis of practice and behaviour will facilitate problem solving in the context of clinical practice. Students are encouraged to develop critical insights into the work of multi-professional teams, and the significance and impact of wider institutional and governmental issues and policies. These approaches seek to broaden outlook and heighten awareness of the application of theory to practice.

Assessment is conducted through a variety of methods, the main components being coursework, unseen examination, observed simulated clinical examination (OSCE) and achievement of practice skills or competencies. Each module has an element of formative learning built into it to prepare them for the summative assessment activities. The specific assessment strategies include, for example, portfolio of clinical practice, OSCE's for vital signs observations, surgical sterile field preparation, presentations of independent learning for infection control and pharmacology. There are also written examinations and assignments for applied science topics and addressing the care provided to perioperative patients.

The Programme Handbook provides a commentary for students on how the Graduate Attributes are developed through the Programme. In addition, students can expect to be introduced to the concept of Graduate Attributes during induction, and will have tutorial discussions with their academic adviser, particularly in their first year, which will focus on identifying module content and activities leading to their acquisition of Graduate Attributes, and their experience of them.

## **Assessment regulations**

The programme conforms to the University Regulations Undergraduates Modular Academic Regulations for the award of BSc (Hons).

#### SECTION 6: ADMISSION TO THE PROGRAMME

#### 6.1 ENTRY REQUIREMENTS

The BSc (Hons) Operating Department Practice programme, Gibraltar is designed to meet the need of Her Majesty's Government of Gibraltar to develop Operating Department Practitioners (ODPs) from within the population of Gibraltar.

The provision is based on a funded model with recruitment of Gibraltar citizens who have lived in Gibraltar for at least five years prior to application and who also work for the Gibraltar Health Authority.

Successful applicants will have their course fees paid and salary support funded by Her Majesty's Government of Gibraltar.

Applicants from outside of Gibraltar and who do not meet the above requirements would need to be fully self-funded and to have evidence of agreed placement support, from the Gibraltar Health Authority.

#### 6.2 DBS AND OTHER PRE-COURSE CHECKS REQUIRED

Securing a place is subject to both a satisfactory **DBS** or equivalent process and **Occupational Health** clearance.

English language requirements: IELTS score of 7 (no section less than 6.5) or equivalents. Please also see the University's Standard English language requirements

## **SECTION 7: PREPARATION FOR EMPLOYMENT**

All graduates are eligible to apply for registration with the HCPC.

Our past experiences with this pre-registration professional group indicate that they are highly employable.

A number of our graduates go on to contribute to health care provision as registered ODPs some have been employed to work independently, for the armed services, independent health care sector, or industry.

Others have continued their studies through post qualification routes in order to undertake advanced clinical, management or teaching roles.
