There is the option for you to continue your studies at Oxford Brookes as a postgraduate student. We have LLM Law courses, as well as postgraduate studies in many different subjects such as International Relations, Politics and Business and many more.

As a graduate of Oxford Brookes University you will be eligible for the following:

- 20% alumni discount for continuing studies at Oxford Brookes
- Graduate visa to work in the UK for up to two years after you graduate

Oxford Brookes graduates have gone on to pursue careers in a range of areas within the law and outside of the law such as in-house lawyers, or working in advertising. Graduates also continue to the Bar Practice Course followed by Chambering (called Pupillage in the UK). The University of Law provides graduate legal professional qualification courses on the Oxford Brookes campus, so you can plan to stay in Oxford and pursue the SQE or Bar Training Course.

Every year we run a Law Fair providing you with the chance to meet employers. And through our LawID programme, you'll also develop the real-world skills to thrive in legal and professional environments through a variety of experiential learning opportunities.

Entry Requirements

Successful completion of a Law course (of English common law) which is equivalent to the first two years of a UK honours degree (240 credits).

BAC: Pass Year 1 and Year 2 exams, re-sits will be considered

ATHE Level 4 & 5 Extended Diplomas in Law: Merit Profile and Land Law at Level 5

Qualifi Extended Diploma in Law: Merit Profile

IELTS 6.5 overall with 6.0 in Reading and Writing, and 5.5 in Listening and Speaking or equivalent SPM, I-GCSE, O-level etc.*

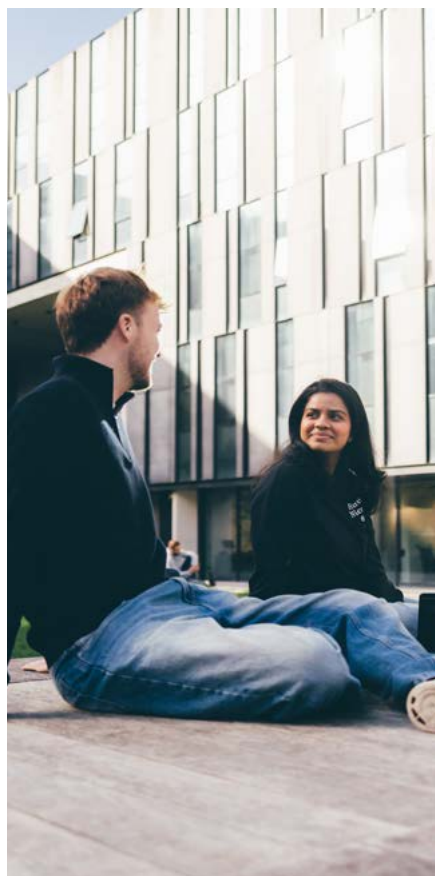
