
# A guide to completing the Student visa application form for applications outside of the UK

The guidance below is to give you an idea of what to expect. You must ensure you complete your application with all your own details. The questions will alter depending on the answers you provide.

NB: Some of the generic steps of the visa application may not be included in this guide since they are straightforward. This guide is updated regularly, however please be aware that the steps might look slightly different when you complete your application.

## Student visa



#### Apply outside the UK

As part of your application, you'll need to prove your identity. How you do this depends on where you're from and what type of passport you have.

You'll either:

- give your fingerprints and a photograph (biometric information) at a <u>visa</u> <u>application centre</u>
- use the 'UK Immigration: ID Check' app to scan your identity documentyou'll also create or sign into your UK Visas and Immigration (UKVI) account

You'll be told what you need to do when you apply.

Once you've started your application, you can save your form and complete it later.

You will be asked to confirm your identity using the free Immigration: ID check app before completing your visa application.

You won't be able to use this app if you don't have a biometric passport or you can't access a smartphone. You will be asked to attend an appointment at a Visa Application Centre after submitting the visa application form.

If you do have a biometric passport or access to a smartphone, you will be guided through the process of scanning your passport and uploading a photo of yourself using the app.

Once you have used the app, you can complete your application either by continuing on your smartphone, or by logging into the UK Visa and Immigration account you created on a different device. You can use this guide to help you answer the questions in the application form.

# Select a country to provide your biometrics

To complete your application, you must provide your biometrics (fingerprints and facial photograph). This may involve attending a visa application centre (VAC) operated by one of our commercial partners.

We need to know which commercial partner will manage your biometrics appointment. This is so we can transfer you to the correct website after you have submitted your visa application.

Enter the country where you would like to provide your biometrics. This will usually be the country you are in now. If there is no VAC in your selected country, you will be able to choose an alternative location.

If you believe you are unable to provide your biometrics at any location, you should still choose a location. You will then be told how to proceed.

#### Check available visa application centre locations



The continued international effort to limit the impact of the coronavirus (COVID-19) pandemic has resulted in the disruption of services at some of the UK's visa application centres. To check the availability of services at your preferred application centre you can find more information by visiting the website of our commercial partner <u>VFS Global</u> who operates our centres around the world.

You can find all VAC locations by checking the <u>'Find a visa application centre'</u> page on GOV.UK. They are also listed on our commercial partners' websites.

You will not be able to change the location after you have submitted your application.

There may not be a VAC in your preferred location. Try an alternative location if this is the case.

You must select a location even if you believe you are unable to provide your biometrics at any location.

You cannot add family members ('dependants') to this application. You must complete a <u>separate form</u> for your dependants.

#### Before you apply

Before you start your application, read the guidance on:

- eligibility
- how to apply and required documents
- fees

How long it takes you to complete the application will depend on your particular situation. You will be able to save your application and come back to it at another time if you need to.

If you are inactive for 25 minutes you will be automatically logged out.

#### How we use your data

The Home Office will use the personal information you provide to decide whether to grant your application. We may also share your information with other public and private sector organisations in the UK and overseas. For more detail please see the <a href="Privacy Notice">Privacy Notice for the Border, Immigration and Citizenship system</a>. This also sets out your rights under the Data Protection Act 2018 and explains how you can access your personal information and complain if you have concerns about how we are using it.

Please note that you are only able to have dependants on a Student visa if you are studying on a postgraduate course that is longer than nine months.

Your family name is the surname shared by your family.

Your passport must be valid when you make your application and it must contain at least a full page that is blank on both sides.

If your passport is due to expire shortly after you arrive in the UK it is advisable that you renew it before you travel (**before you apply for your visa**)

If your passport will expire while you are in the UK you should check with the passport issuing authority in your home country that you would be able to renew it in the UK.

- if you were a student, your sponsor confirmed on your CAS that you met the required level

If your visa application is successful you will be given a 'vignette' that will indicate the dates you can enter the UK and will be valid for 90 days (if you course lasts for less than 6 months your vignette will be valid for the whole of your stay).

If you are applying for a course that lasts six months or more, your temporary visa (vignette\*) will start 30 days before the start of your course or 7 days before the date of your intended travel, whichever is later. If you enter your intended date of travel as less than 30 days before your course starts, your visa will start 7 days before this date and you will not get the maximum period of leave possible before your course starts.

You must travel to the UK within the 90 days period given on your vignette, if you do not you must apply for a replacement vignette and a fee is charged for this.

It is very important that you answer these questions honestly, as if you withhold information your visa will be refused. If you are unsure if these problems apply to a situation that you have been in, please contact ISAT who will be happy to discuss this with you.

## **Breach of UK immigration law**

- On the next three pages you will be asked if you have had any involvement or been suspected of involvement in war crimes, terrorist activities, terrorist organisations or hold any terrorist views. You will also be asked about any involvement with Extremist organisations or hold any Extremist views. Please answer these questions honestly as your visa application will be refused if you are found to have withheld any information. If you have any questions or concerns please contact ISAT.
- You will be asked questions relating to you being a **person of good character**. You will be asked to declare any involvement you have in activities that would indicate if you are not a person of good character. Again it is important to be honest and if contact ISAT you are unsure how to answer.
- You will be asked about your **employment history**. If you have worked (either paid or unpaid) for any of the types of organisations listed you will be asked to give details. Make sure you are honest in your answers. If you have not worked for any of the listed organisations you can tick 'I have not worked in any of the jobs listed above'.

<u>Non-EU nationals</u> will receive a 90-day entry-permit vignette in the passport and you will be issued with a Biometric resident permit (BRP) which will be posted to you when you are inside the UK if you requested it be sent to the university.

### If your visa is refused:

If the UKVI refuses your visa application, the UKVI will provide you with a Refusal Notice which will explain the reasons for your refusal. Please send a copy of every page of this letter to <a href="mailto:isat@brookes.ac.uk">isat@brookes.ac.uk</a> along with your name and student number, and the International Student Advice team can advise you of your options.

Please note that you can only use a CAS once, so if your application is refused and you are able to make another application, you will need a new CAS number.
